A. NSGM Smart Grid Projects

- 1. **CED, Chandigarh:** Financial bids evaluated for all packages (AMI, SCADA and DTMS). Snap bidding initiated on 24th October 2017.
- 2. **MSEDCL, Maharashtra:** Tenders are live for SG projects at Amravati and Congress Nagar (Nagpur). Technical bid opening rescheduled for 6th November 2017.
- 3. **KSECO**, **Kanpur**: Utility representative intimated unwillingness of implementation of sanctioned SG project by KSECO during review meeting held on 24th October 2017.
