- 2. **Tripura, TSECL**: Monitoring Committee of IPDS in its 23<sup>rd</sup> meeting under Chairmanship of Secretary (Power) held on 22<sup>nd</sup> March 2022 decided that no further funding will be available under IPDS for Agartala Smart Grid Pilot and utility to complete balance project from its own resources.
