

Monthly Exception Report – October 2024 NSGM Project Management Unit

A. NSGM Smart Grid Projects

- 1. **JVVNL, Rajasthan:** Project O&M commenced from 1st November 2023. The project was completed with 1,45,343 Smart Meters and final tranche grant released in March 2024. JVVNL submitted DRC approval/recommendations for JVVNL Smart Grid Project sanctioned under NSGM. JVVNL submitted final tranche grant Utilization Certificate.
- 2. **CED Chandigarh (Sub-Division 5)**: All Smart Meters as per surveyed quantity (24,214) installed in field. O&M of already installed meters commenced from 1st July 2023. Inspection for balance 61 nos. of Smart Feeder Meters completed and dispatched to Chandigarh for installation.
